

- Scholarships will be available to all new full-time UK students applying for undergraduate courses at Swansea University (exceptions apply, see below);
- Each Excellence Scholarship will be worth £3,000 over three years (with £1,000 payable in the first year, £1,000 payable in the second year and a further £1,000 payable in the third year);
- Each Merit Scholarship will be worth £2,000 over three years (with £670 payable in the first year, £670 payable in the second year and a further £670 payable in the second year);
- Students will need to meet the 60% overall average with a minimum of 55% in every module progression requirement at the end of the first and second year in order to receive their second and third instalments; If a student fails to achieve an overall average of 60%, with a minimum of 55% in each module in any given year, the scholarship will be terminated. Achievement of an equivalent grade in the Welsh Baccalaureate Advanced qualification is recognised for the purposes of the award;
- Scholarships will be available in all subject areas (single, joint and combined honours), with the exception of programmes that attract external funding for all or part of the course (e.g. Social Work, Graduate Entry Medicine, Nursing/Midwifery) from the respective professional bodies;
- Application procedure: Any student who applies and achieves AAA (Excellence) or AAB (Merit) at A-Level or equivalent (excluding A-level General Studies) will automatically be awarded a scholarship. The scholarship must be accepted, and bank details entered into the University's finance system, by the end of the student's first term. Failure to meet either requirement by this deadline will result in the withdrawal of the scholarship offer.

SWANSEA UNIVERSITY UNDERGRADUATE EXCELLENCE SCHOLARSHIP SCHEME
 ELIGIBILITY, TERMS AND CONDITIONS Eligibility:

1. The Scholarships will be open to full-time UK undergraduate students only.
2. Scholarships will be awarded by the Recruitment and Admissions Committee to candidates who, in the view of the Committee, have demonstrated the most exceptional academic ability.
3. Scholarships will be available in all subject areas (single and joint honours), with the exception of Medicine, Social Work and courses in the courses within the Faculty of Medicine, Health and Life Sciences where fees are funded by the respective professional bodies .
4. The following candidates are NOT eligible for a Scholarship: Exchange students, Visiting/Associate students (including English Language students) and students who had previously been admitted as full-time students of the University or any other university or equivalent institution.

Terms and Conditions:

1. Each Excellence Scholarship will be worth £3,000 over three years (with £1,000 payable in the first year, £1,000 payable in the second year and a further £1,000 payable in the final year)
2. Each Merit Scholarship will be worth £2,000 over three years (with £670 payable in the first year, £670 payable in the second year and a further £670 payable in the final year).
3. Scholarships may be held in addition to, and concurrently with, any other award which the Scholarship holder may receive from local education and/or other grant awarding bodies.
4. Scholarship holders, having accepted an award, may be contacted by the University's Marketing Department. The scholarship must be accepted, and bank details entered into the University's finance system, by the end of the student's first term. Failure to meet either requirement by this deadline will result in the withdrawal of the scholarship offer.

5. Having accepted an award, should a Scholarship holder withdraw from the University, the holder will be liable to repay to the University any award which has been made, either in whole or in part, as determined by the Committee.

6. Students will need to meet the an overall average of 60%, with a minimum of 55% in each module requirement at the end of the first and second year in order to receive their second and third instalments. ; If a student fails to achieve an overall average of 60%, with a minimum of 55% in each module in any given year, the scholarship will be terminated.;

7. With the approval of the Vice-Chancellor or nominee, if a Scholarship holder's progress is deemed unsatisfactory, the Scholarship may be withdrawn. If the student feels that such a withdrawal is unjustified, s/he may appeal in writing, using the University's formal appeal mechanism.

8. If, in the view of the Committee, there are few or no candidates of sufficient merit the Senate reserves the right to withhold some or all of the Scholarships.

9. Senate reserves the right to make, amend, withdraw, suspend or cancel without notice these and such other Regulations as may be in force from time to time and such decisions shall be final.
